Information pursuant to Article 13 of European Regulation 679/2016

Thank you for visiting the website of **Giotto Technologies Srl** (hereinafter referred to as "Giotto Technologies," "we," or "the Website"). This Privacy Policy describes how we process personal data collected through the Website and outlines the rights and options available to users regarding their personal data.

Types of Personal Data Collected

During the browsing and use of the Website, we may collect and process the following personal data:

- Information voluntarily provided by users through the contact form, including name, email address, phone number, and any other information entered in the contact request.
- Technical information, including IP address, browser type, language settings, login data, and details about the device used to access the Website.
- Information collected automatically through the use of cookies and tracking technologies. For further details, please refer to our Cookie Policy.

Purposes of Processing

The personal data collected through the Website is processed for the following purposes:

- Responding to user contact requests and providing requested assistance or information.
- Improving and personalizing the user's browsing experience on the Website.
- Monitoring and analyzing the use of the Website for statistical and improvement purposes.
- Maintaining the security of the Website and preventing fraud or improper use.
- Complying with legal obligations and requests from competent authorities.





Legal Basis for Processing

The processing of user personal data is carried out based on the following legal bases:

- Performance of a contract: If users request information or assistance through the contact form, the processing of personal data is necessary to respond to the requests.
- Consent: If the user has provided consent for the processing of personal data, such as accepting the use of cookies through the appropriate banner.
- Legitimate interest: The processing of personal data for monitoring and improving the Website is based on our legitimate interests in providing a quality and secure experience to users.

Sharing of Personal Data

The personal data collected through the Website may be shared with third parties only for the following purposes:

- Service providers: We may share personal data with external service providers who perform activities on our behalf, such as website hosting or data analysis.
- Competent authorities: We may disclose personal data if required by applicable laws or regulations or if necessary to protect our legal rights or respond to requests from competent authorities.

Data Security

Giotto Technologies implements technical, organizational, and procedural security measures to protect user personal data from unauthorized access, loss, or unlawful disclosure. However, no transmission or storage system can guarantee complete and absolute protection.
